PRIVATE SECTOR TASKFORCE SUPPORT

The office was overwhelmed with visitors during February, primarily sole traders, who we endeavoured to get registered with RMD and CINSF, and assisted with financial records where we could. Unfortunately for many, they will not be eligible for assistance as they did not keep records of their financial activities.

We attended several meetings, along with MFEM and INTAFF, to explain what the criteria was, what records where required, and what social protection benefits may be available. Registration was required to be completed by the end of February, and applications must be completed by the end of May. We have met with the new Director of Economic Planning for MFEM, Dr Pim Borren, several times now, and he understands the role the Chamber continues to play in assisting all businesses and providing recommendations for government regarding priorities for the private sector in general.





COOKSAFE

The rollout and promotion of CookSafe continues, as do the audits. These are done to minimise issues and quickly resolve them if they do arise. We encourage you to nominate a CookSafe champion in your business so that we can focus on training them to make sure the device is powered and up and running for users to tag in. Aitutaki and now Mangaia continue to grow, and with our recent competition in Aitutaki, their tag-in numbers were over 500 last week alone. The total number of tag-ins now sits at more than 100,000 and we are averaging more than 5000 per week.

You may have heard us mention the enhancement to CookSafe with the introduction of Bluetooth in a Cook Islands app. This will be known as CookSafe+. When downloaded, the app works by sending out a private and secure random ID code. The Bluetooth tracing function records how close the other phone was, and for how long. This will only work if the phones you come into contact with have Bluetooth tracing turned on as well. This means that if someone tests positive for COVID-19, they can send an anonymous notification containing all the random IDs their phone has sent out over the past 14 days. If your phone recognises any of these IDs, and you had been close enough for long enough to be at risk of exposure, you will receive an alert. This alert will advise you on what to do to keep you and your family safe. We are expecting to rollout and promote CookSafe+ during March. Once introduced, it will be important that you continue to use CookSafe. CookSafe+ just adds that one additional functionality of Bluetooth. The app can also be used in NZ if you are visiting there and, conversely, visitors from NZ will be able to use the NZ app here in the Cook Islands. We will be encouraging visitors from NZ to also sign up for CookSafe so that we can trace what locations they have been to and who may have been there at the same time if need be.

MINIMUM WAGE REVIEW

The 2021-2022 Minimum Wage Review has now been completed. The Chamber conducted a survey to ascertain the appetite for any change from the private sector. We received 103 responses, and while the majority of respondents were currently paying their employees above the minimum wage, many mentioned that any rise would have to see a corresponding rise in the wage subsidy.

There were also concerns about the effect on the government's payroll and its affordability, and that it was simply not the right time to consider a rise. The panel conducted public consultation meetings, radio talkback and meetings with the panel members, who consisted of MFEM, Community, Workers, and Chamber for the Employers. Our recommendation was that there should be no change at this time and that we should review again in 2022.

LONG-TERM VISITOR STAY PROJECT

We have had no progress with this project, and it seems there is little appetite from either our government or New Zealand's to consider anything ahead of two-way quarantine-free travel (QFT). This is disappointing as it would have given us the opportunity of some economic activity in the interim. Unfortunately, border controls are inflexible at this time. We will continue to work on this so we can hit the ground running when two-way QFT is achieved. The recent survey for Long-Term Visitor Stays was designed to see what appetite there was for longer-term stays and 90% of the 51 responses received indicated that they were interested in providing longer-term stay accommodation – which definitely demonstrates some keen interest from a significant number of accommodation providers.

NATIONAL LABOUR ADVISORY BOARD (NLAB)

We attended the first meeting of the NLAB last week. The Employer's Representatives this year are myself, Fletcher Melvin, and Eileen Turepu. This Board is made up of representatives from the CI Workers Association (CIWA), Internal Affairs, MFEM, MFAI, and the Public Service Commission. Matters discussed included:

- Chamber proposed that a representative for migrant workers be appointed and this is being considered.
- Workplace Health and Safety bill is still delayed with Crown Law.
- Social Protection Agenda funds have been received from International Labour Organisation (ILO) to support Employment Services and to fund Employment Mediation Services as a pilot programme. The Cook Islands will be ratifying Convention C102, which is the Social Security Convention.
- · Minimum Wage Review.

- Labour force movement to New Zealand being a concern.
- · Issues and costs around migrant worker portability. Board recommended that a collective statement be made and some solutions suggested.
- · Chamber programme supported by ILO to provide training and support to micro-enterprises to assist in formalising their businesses (subject to ILO funding).
- · Chamber programme Ready2Work to provide some skills and training for those finding difficulty in getting employment (subject to funding).
