Gilbert Enoka has a long history of success as a mental skills coach with New Zealand's corporate and sporting elite. He is internationally renowned for his 23-year history with the All Blacks, first as their mental skills coach and then as All Blacks Manager - Leadership. He has been with the All Blacks for over 300 tests and during that time the team has won back-to-back Rugby World Cups, a very close runner up in 2023, one Laureus Award (for the best team in the world), 21 consecutive Bledisloe Cups, three Grand Slams, eight Tri Nations and Nine Rugby Championships.

Gilbert has worked as a mental skills coach for the All Blacks, Canterbury Crusaders, the Silver Ferns and the Black Caps and strongly believes that players who are mentally prepared will perform better on the day. Gilbert is currently consulting with Chelsea Football club in the UK.

He has also worked as a highly skilled practitioner, working on performance enhancement for over thirty years with top CEO's, businesses, and sporting elite.

2023 Annual General Meeting

The well attended meeting heard from the out-going Chair, Phillip Henderson, who said: "The Islands Cook continue to persevere in its recovery from one of the most challenging economic disruptions in our history. We are absorbing the shock of increasing inflation, restricted labour forces and a slow return of flights and visiting tourists to our shores to name a few."

Reports on the last 12 months highlighted Chamber's involvement with the National Labour Advisory Board, Liquor Licensing, Superannuation, Land Agents Registration, Marae Moana Council, ASYCUDA and the Minimum Wage Review.

Of considerable importance was the Chamber's representations to government regarding revisions to the Immigration Regulations, with announcements on this expected soon. The Chamber also 99 small local supported businesses by facilitating grants for them from Business Link Pacific.

Mr Henderson said "With a number of our COVID related funding streams coming to their natural conclusion, we've seen a change in staffing levels and activities.

However, our goals remain ambitious, our business needs are great, and there is still more to do to ensure a prosperous Business economy for our members."

A strategic plan was presented that included improving value for membership, having a consistent voice, monitoring the economy, maintaining a productive working relationship with government and promoting good governance.

Some specific actions for the coming year are to work with Government on mechanisms to manage credit card fees, to review the BTIB fee structure, and to engage on the proposed water metering mechanism and tariff.

The Chamber also celebrates its 40th anniversary shortly, and a major event is planned.

New Chair Addrienne Hosking-Tinirau thanked the outgoing Chair for his tireless work for the Chamber, welcomed the incoming team, and is determined to set a fast-track pace for the work ahead.

The meeting concluded with a social event sponsored by Vodafone, BSP and Edgewater.

Updates

Immigration Regulations

Chamber of Commerce, along with the Tourism Industry Council, made a number of submissions to Cabinet with regard to the recently promulgated Immigration Regulations. The Chamber understands that the concerns raised have had a favourable hearing, and an announcement from Government, while delayed by the recent Forum Leaders' Meeting, is expected soon.

Fringe Benefit Tax

A number of Chamber members have contacted the board with regard to new and wider interpretations of 'fringe benefits' and their taxability.

The Chamber is taking advice on this matter, particularly on the fairness of the new stance being taken. Chamber welcomes input from any business regarding how the new interpretations are affecting their business, and any concerns they might have.

Water Metering

Some businesses in the Arorangi area have noticed that meters are now being fitted to their incoming water mains. The Chamber has concerns regarding heard upcoming water tariffs, and has had an initial discussion with To Tatou Vai (TTV) to raise these matters. Further dialogue is expected, with an opportunity for full consultation before the TTV's tariff policy is formulated. In any event, Chamber is advised that billing for water is not imminent.
